College Managing Committee, Chitra Gupta Road, New Delhi, in a befitting ceremony. The Management of the Dayanand Arya Girls Education Society (Regd.) Karnal, after due consideration in the wider interest of the Society had decided to the handing over of all these institutions in a Public Function held on 20.2.1986 at D.A.V. College for Women, Karnal to the President, D.A.V. College Managing Committee, New Delhi. It is hereby resolved that the direct control of all the above institutions be and is hereby taken over by the D.A.V. College Managing Committee, New Delhi. All assets and liabilities including all movable & immovable property of these institutions taken over by this Society hereby passes on to the D.A.V. College Managing Committee, Chitra Gupta Road, New Delhi.
