(Change of Name)

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **D.A.V. College of Education for Women, Railway Road, Karnal – 132001, Haryana** was granted recognition for B.Ed. programme of one year duration with an annual intake of 140 students *vide* order No. F-3/H.R.03/B.Ed./2000/5106-13 dated 26.07.2000 followed by revised recognition order for B.Ed. programme of two year duration with an annual intake of 150 students i.e. three basic units of 50 students each from the academic session 2015-2016 *vide* order No. F.No.NRC/NCTE/HR-03/2015/115599-603 dated 09.06.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, the institution *vide* its letter dated 06.10.2025 requested regarding change of the name of the institution from **D.A.V College of Education for Women, Railway Road, Karnal - 132 001** to **Dr. Ganesh Dass D.A.V. College of Education for Women, Railway Road, Karnal - 132001, Haryana.**

3. AND WHEREAS, the matter was placed before NRC in its 449th meeting (Volume-III) of NRC held on 13th & 14th October 2025 and the Committee decided as under:

“The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely **D.A.V College of Education for Women, Railway Road, Karnal - 132001** for offering B.Ed. course of one year duration with an annual intake of 140 students *vide* order dated 26.07.2000 followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 150 students (3 unit) *vide* order dated 09.06.2015.
- The institution *vide* letter dated 06.10.2025 has requested to change the name of the institution from **D.A.V. College of Education for Women** to **Dr. Ganesh Dass D.A.V. College of Education for Women.**

*In view of the above, the Committee considered the matter of the institution and decided to permit the name of the institution be changed from **D.A.V. College of Education for Women** to **Dr. Ganesh Dass D.A.V. College of Education for Women** at Railway Road, Karnal – 132001 for offering B.Ed. course of two-year duration with an annual intake of 150 students i.e. 3 basic units of 50 students each.*
